- Sponsored non-commercial show means the exhibitions of registered art societies and other organizations which are non-profit making organizations.
 - Sponsored commercial means exhibitions sponsored by commercial art galleries and other profit-making organisations.
2. The application form shall be signed by the person who wishes to make use of the Gallery or represents the organisation or group, wishing to exhibit in the gallery. Application form is not transferable.
 3. Allotment of exhibitions space are made by a special booking committee consisting of senior artists and experts in the field.
 4. The Booking Committee will meet twice a year and will make allotment for only six months for the following year, at each meeting.
 5. At every meeting, exhibition space will be offered to artists or art institutions which are considered to be most deserving among the applicants. Every effort will be made to accommodate all those artists or art institutions approved by our committee. Those who cannot be accommodated will be put on a waiting list and will be offered gallery space against cancellations.
 6. The booking committee reserves the discretion of refusal of any application. Rejection of an application, however, is not an aspersion on the quality of artist's work.
 7. The gallery administration will write to each applicant regarding the decision.
 8. As an essential convention an artist is allotted gallery space only once in three years due to the large number of applications.
 9. Applicants will be intimated by the gallery regarding submission of their specimens. (Do not send the slides, images, photographs, biodata along with the application). The booking committee reserves the discretion of refusal of any application.
 10. w.e.f 2010 commercial galleries will be allotted exhibition space after a period of 2 years.
 11. Major art societies which have been organizing their annual shows for decades are exempted from rule no. 8 & 9
 12. The committee will allot normally seven days per exhibition and reserves the right to allot any gallery as per its discretion.
 13. Application forms will be issues in the month of September. The applicants have to pay and fill the application online and then make a printout. The same should be submitted in the office in the same year. From 1st to 31st December.
